(The PCI is computed as follows: Total net income of everyone in the household divided by the number of people in the household).• Full-time student in a government school.• Not receiving any other form of financial assistance/awards – e.g. HOPE (Home Ownership PLUS Education) Scheme; School Pocket Money Fund (SPMF); MOE/School/SHG financial assistance; etc.
Remarks	<ul style="list-style-type: none">• To apply for the award by the stipulated deadline using the attached Application Form and submitted with the recommendation of the School Principal.• Award recipients will be invited in January 2019 to receive the award or their privilege to the award shall be forfeited. 
Disbursement of Awards
