CTS Education Awards

Frequently Asked Questions

Eligibility Criteria

1. Can all students apply for CTS Education Awards?

All full-time students studying in MOE-Approved institutions who are Singapore Citizens / Permanent Residents are eligible to apply.

2. What is the criteria for CTS Education Awards (Bursary and Scholarship)?

There are no specific criteria in terms of the minimum PCI and scores for Bursary and Scholarship Applications respectively. Since, the applications will be considered in competitive merit based on the pool of applications received for the current year, the criteria is bound to change every year. Thus, students are welcomed to apply for the awards with the necessary supporting documents as stated in the Checklist Forms.

Application

3. Can I apply for both scholarship and bursary?

Students can apply for both Bursary and Scholarship. For that, they need to submit two different application forms online. As both applications are processed independently, it is much appreciated if students can attach two sets of the required supporting documents with the two checklists accordingly. While students can apply for both Bursary and Scholarship, they will be awarded only one. If they qualify for both, the award with the higher quantum will be presented.
